A RESOLUTION OF THE BOROUGH OF ZELIENOPLE, BUTLER COUNTY, PENNSYLVANIA AMENDING THE RULES AND REGULATIONS GOVERNING THE ZELIENOPLE COMMUNITY PARK AS PROVIDED IN ORDINANCE NO. 773-06.

WHEREAS, the Zelienople Borough Council may deem it appropriate to amend/modify the regulations from time to time concerning the governing of the Zelienople Community Park, and

WHEREAS, there has been vandalism and costly damage done to Community Park facilities as well as graffiti and improper behavior resulting in a fear of use of park facilities especially for young children, and

WHEREAS, the Borough Manager can promulgate Rules and Regulations needed to implement Ordinance #773-06 to maintain the safety and integrity of the park facility, its environs, neighbors and the community at large through Resolution as provided for in Ordinance No. 773-06, and

NOW, THEREFORE, BE IT RESOLVED:

The Borough Manager recommends the following amendments to the Community Park Rules & Regulations to read:

Part I. Section A. Hours. (Amended) All park public open spaces and recreation areas shall be open to the public **between the hours of 6:00 AM to Dusk**, and no person or persons shall be in, on, or about the above premises during the prohibited time. **The exception to the hours would be to individuals or groups that have permits for the pavilions, with a closing time of 11:00 PM.**

Part I, Section O. Amplification and sound systems (Amended) When amplifying or sound systems are used, the maximum time permitted shall be between the hours of 10:00 AM to 11:00PM, Monday through Saturday, and 1:00PM to 11:00 PM on Sunday, **for permitted locations only**. Noise levels which disturb the peace are not permitted,

Part I, Section P. Tobacco free zone (New Provision) ***The Community Park is a tobacco/smoke free zone. Exceptions are: 1) the possession of an Alcohol and Tobacco permit for rentals where it must remain within the confines of the permitted areas and 2) The area in front of the pool house will remain as a designated smoking area.***

Part II, Section F. Age 12 and under Play Zone (New Provision) ***The age 12 and under play zone is located on the N.W. Corner of E. Beaver Street and Park Drive. Only children ages 12 and under with a parent/guardian are permitted in the play zone.***

Any Ordinance, Resolution or part thereof in conflict herewith, is hereby repealed to the extent of said conflict.

RESOLVED AND ENACTED BY THE BOROUGH COUNCIL OF THE BOROUGH OF ZELIENOPLE THIS 25th DAY OF July, 2011 AND ARE EFFECTIVE IMMEDIATELY.
